## *Senior Lifeguard*

(Reports to Head Lifeguard or upper management)

*Salary Range \$8.75-\$10.75/hr*

(Part-time 15-40 hrs per week)

**DEFINITION:** Under general supervision, performs lifeguard duties, enforces all rules and regulations pertaining to the safety and well being of visitors and patrons. Perform related work as required, may include cleaning and janitorial maintenance of the pool and surrounding facility. Reports directly to Head Lifeguard, Pool Manager and Aquatics Director.

### **EXAMPLES OF DUTIES**

- Active scanning and patron surveillance.
- Practice preventive Life guarding.
- Enforce all rules and regulations.
- Recognize and respond professionally to emergencies, provide care as indicated under scope of training.
- Assume assigned duties connected with care and maintenance of facility and pool.
- Maintain certain pool records and reports as required.
- The ability to speak English clearly and understandably.
- Perform related duties as required, basic maintenance, equipment care and chemical pool testing.
- Deal tactfully and courteously with the public.
- Establish and maintain effective working relationships with other Limited District employees, other agencies and the general public.
- Actively attend and participate in required staff trainings and in-service drills.

**TRAINING/EXPERIENCE/REQUIREMENTS:** Lifeguards must be a minimum of 15 years old and possess current American Red Cross Lifeguard and First Aid Certification, as well as CPR/AED for the Professional Rescuer. Must be able to lift 50 lbs. and react quickly to emergencies.
