Director Burke moved to approve the November 2013 cash disbursement report, Director Grampp seconded. Motion carried.

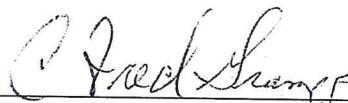
**H. Investment Reports: October 2013**
